#### **Rules & Regulations**

It is the responsibility of all those registering to be aware of and accept these regulations.

#### 1. Contract for Space

Applicants for exhibit space are required to complete the application with full payment to confirm space reservations. Upon receipt of application and full payment, space will be confirmed and the exhibitor will be notified in writing.

#### 2. Cancellation

A full refund (less \$50 for processing) will be granted for space canceled in writing by Monday, March 20, 2020. All cancellations must be received by email before end of this day, otherwise a refund will not be granted.

#### 3. Exhibitor's Admission Credentials

Exhibitors shall supply CIAAA with an advance list of attending representative(s). Forms will be provided by the CIAAA for this list. Every person must individually register upon arrival on Friday morning, to receive their credentials. Conference credentials must be worn at all times.

#### 4. Facility Rules and Regulations

Nothing shall be nailed, stapled, hung or attached to ceilings, walls or columns, trim or other painted surfaces, nor will the penetration of floor, walls, columns, ceilings, or trim be permitted in any portion of the building. Exhibitors and/or their agents shall not damage or deface equipment provided by the CIAAA or the hotel. When such damage occurs, resulting costs will be charged directly to the liable party.

#### 5. Insurance

Exhibitors and any independent contractors they may employ must have comprehensive insurance. Neither CIAAA nor the Hotel maintains insurance covering the exhibitor's property. Although CIAAA provides a secure space, be advised that displays and materials belonging to the exhibitor are the responsibility of the exhibitor at all times, and insurance for any loss or damage should be carried on these items.

#### 6. Brand

Use of the CIAAA name, logo, or acronym for any purpose must be authorized in writing by the CIAAA.

#### 7. Part of Contract

These rules and regulations constitute a bona fide part of the contract for space entered into by applying and providing payment. The CIAAA reserves the right to render interpretations and decisions and to make such additional rules and regulations as deemed necessary to enhance the success of the conference or decline any exhibit which, in its judgment, is out of keeping with the character of the conference. The CIAAA's decision and interpretations shall be accepted as final in all cases.
